ITEM #1 – WORK SESSION – FLOODPLAIN VIOLATIONS

Rod Compton, Planning & Development Director, came before the Board to discuss countywide Floodplain violations. In 2010, the Kansas Department of Agriculture, Division of Water Resources, made a Community Assistance Visit to Wagon Wheel Ranch because of the 2009 flood. The County was already aware of some non-compliance in the area. Failure to enforce the regulations could result in the County being removed from the National Flood Insurance Program, which would mean that no flood insurance would be available for residents of the unincorporated area of the County. Mr. Compton will respond to the State and, as a State requirement, will send notices asking the property owners involved to provide information on repairs. The Board requested a list of the property owners affected. No action was taken.
